Can I remind all clubs that may appear in semi-finals and finals of cups of Rule 46 (page 61 of the handbook) please where the registration of players changes slightly;

46. QUALIFICATION RULES for CHALLENGE CUP COMPETITION

For all Challenge Cup competitions all players must be registered in the same season for the competing club prior to each match. For the semi-final and final, the registration must be completed a clear twenty eight days or four games, whichever is less, prior to the playing of the tie. No player shall play for more than one club in any one of the following competitions.

Transfer Deadline Day – As per rule the transfer deadline is 28th February. Reminder to clubs that have transferred players that if that player has played in any cups you are still involved with he will be cup tied

Player Registration Deadline Day – Last day for player registrations is 30th April.

Match Procedures - New Referees especially to note;

- Home club to confirm by Tuesday. Failure to do so by Wednesday please contact Mike Parr.
- Match day. Arrive at ground no later than 30 minutes before kick off.
- Match report to be given to you in dressing room before the start of the game, completed by both teams including the substitutes.
- After game you are to fill in the score and record any sending off's or cautions in the appropriate boxes on the bottom of the form.
- The home club to collect form and pay you in dressing room, normally within 15/20 minutes after the final whistle.
- All misconduct to be reported to BCFA within 2 days.

Referee fees this season are £28 & £19 an assistant. Could I please remind clubs that the Match Form must be completed & handed to or placed in the referee's room BEFORE the match. Furthermore referees must be paid their fee ASAP after the match and not be expected "to hunt the club down" for their fee!!

COULD ALL CLUBS PLEASE CONTACT EACH OTHER AND THE REFEREE A CLEAR 5 DAYS BEFORE THE FIXTURE!!
