ANY TEAM REACHING **25** POINTS AND THEN EVERY **25** POINTS THEREAFTER WILL BE CALLED TO ATTEND A DISCIPLINARY HEARING.

<b>ANY CLUB CALLED TO ATTEND A DISCIPLINARY HEARING WILL BE FINED AS FOLLOWS;</b>	FIRST APPEARANCE	MAXIMUM £35
	SECOND APPEARANCE	MAXIMUM £70
	THIRD APPEARANCE	MAXIMUM £100

**\*\*All teams that are called to attend a disciplinary hearing may be charged an Admin Fee of £15.00\*\***

### POINTS GUIDELINE

UNSPORTING BEHAVIOUR; PERSISTENT INFRINGEMENT; DELAYS RESTART OF PLAY; FAILS TO RESPECT THE REQUIRED DISTANCE; ENTERS/ RE-ENTERS PLAY WITHOUT PERMISSION	<b>1 POINT</b>
INCURRING 5 DISCIPLINARY ACTIONS ( <i>Cautions/ Dismissals/Misconduct</i> ) ON THE MATCH FORM	<b>2 POINTS</b>
DISSENT (Sin Bin)	<b>3 POINTS</b>
STOPPING GOALSCORING OPPORTUNITY ( <i>Hand or Foul</i> )	<b>3 POINTS</b>
DISMISSAL FOR TWO BOOKABLE OFFENCES	<b>4 POINTS</b>
SERIOUS FOUL PLAY ( <i>Dangerous Tackle</i> )	<b>6 POINTS</b>
FOUL AND ABUSIVE LANGUAGE	<b>10 POINTS</b>
VIOLENT CONDUCT	<b>10 POINTS</b>

SPITTING*	<b>10 POINTS &amp; IMMEDIATE CALL</b>
ASSAULT ON MATCH OFFICIAL*	<b>IMMEDIATE CALL</b>
CAUSING A GAME TO BE ABANDONED*	<b>IMMEDIATE CALL</b>

**ANY TEAM FOUND GUILTY OF MISCONDUCT (AS SET OUT IN THE FA DISCIPLINARY GUIDELINE) BY THEIR COUNTY FA FOR MISBEHAVIOUR BY THEIR PLAYERS/ CLUB OFFICIALS/ SPECTATORS WILL HAVE THE FOLLOWING POINTS ADDED TO THEIR RECORD**

<b>E3 (1)</b>	Improper Conduct against a Referee (inc. abusive language/ behaviour)	<b>3 POINTS</b>
<b>E3 (2)</b>	Improper Conduct (not including threatening &/or abusive language/ behaviour)	<b>3 POINTS</b>
<b>E3 (3)</b>	Improper Conduct against a Referee (inc. threatening &/or abusive language/ behaviour)	<b>10 POINTS</b>
<b>E3 (4)</b>	Improper Conduct (inc. threatening &/or abusive language/ behaviour)	<b>10 POINTS</b>
<b>E3 (5)</b>	Improper Conduct against a Referee (inc. physical conduct, violent conduct and threatening &/or abusive language/ behaviour)	<b>10 POINTS</b>
<b>E3 (6)</b>	Improper Conduct (inc. violent conduct & threatening &/or abusive language/ behaviour)	<b>10 POINTS</b>
<b>E3 (7)</b>	Improper Conduct (inc. foul & abusive language)	<b>10 POINTS</b>
<b>E3 (8)</b>	Assault by Participant on Participant	<b>10 POINTS</b>
<b>E3 (9)</b>	Assault on Match Official	<b>10 POINTS</b>
<b>E4 (10)</b>	Discrimination on the grounds of origin/ colour/ race/ nationality/ religion/ sex/ sexual orientation/ disability etc..	<b>10 POINTS</b>
<b>E10 (11)</b>	Failed to comply with a decision of the Association (player charge)	<b>6 POINTS</b>
<b>E12 (12)</b>	Failed to comply with a decision of the Association (club charge)	<b>6 POINTS</b>
<b>E20 (13)</b>	Failed to ensure Players/ Spectators &/ or Club Officials conducted themselves in an orderly fashion	<b>6 POINTS</b>
